1 • Composition of the Sustainable Development Committee

On May 8, 2024, the board of directors of the company resolved to establish a sustainable development committee, which is the highest guiding organization for the company's sustainable governance operations. All members are directors, including two directors and three independent directors. The Taiwan Liaison Office serves as a development center, gradually and effectively promoting the setting and implementation of the Group's overall sustainable development goals and integrating ESG concepts into business strategies. Submit reports to the board of directors regularly (at least once a year) to report on the ESG implementation plan and promotion results.

The committee consists of four functional groups, namely the "Corporate Governance Group", the "Sustainable Environment Group", the "Social Welfare Group" and the "Sustainable Information Disclosure Group". The heads of the relevant functional units are responsible for promoting various Projects or measures to respond to major issues in various aspects, effectively integrate resources and implement them in daily operations.

On December 25, 2024, the convener of the Sustainability Committee will report the ESG implementation and annual work plan to the Board of Directors, and the Board of Directors will then evaluate the plan, review the progress, and make adjustment recommendations.
